

**Please Read:**

Before filling out the pre-registration form, please read the information below carefully.

- Please print clearly and provide **all** information requested on the forms attached.

**Prerequisite:**

**If you have not held an I-CAR Automotive Aluminium GMA (MIG) Welding Qualification before, then you are required to complete the online self study 'Aluminium GMA Welding Theory' course prior to the practical assessment.**

**Payment and Pre-Registration:**

- Pre-payment and pre-registration is required to take the Automotive Aluminium GMA (MIG) Welding Qualification Assessment. The cost of the assessment for the first person is \$1,091.00 + GST. Second and subsequent registrations at the same time are \$926.00 + GST.
- Payment by direct credit (I-CAR New Zealand Trust, ASB, 12-3152-0180972-00) or by credit card.
- Please ensure that the registered participant reads the 'Hold Harmless Agreement' on the pre-registration form.
- One to two weeks after I-CAR NZ receives your payment and pre-registration form, you will receive information outlining the seven welds required for the assessment, an I-CAR Aluminium MIG welding gauge to assist you in preparing for the assessment and a pack of aluminium coupons for practicing purposes. The 'Aluminium GMA Welding Theory' course will be available for you to complete online through myI-CAR. When you have successfully passed this theory course then your on-site assessment will be done. The assessment is skills-driven so please make time to practice the skills required.

**Assessment Date:**

- Normally within 60 days after receiving your registration pack for the weld assessment, an I-CAR NZ Instructor will contact you to make a date for the assessment to be completed. This assessment will be conducted at your work place using your welder. The Instructor will bring the pre-marked aluminium coupons to be welded and the welding support stand. (Please refer to the Automotive Aluminium GMA (MIG) Welding Qualification Assessment Checklist form outlining equipment and health and safety requirements).
- Participants must perform all seven welds as shown in the assessment information using the correct gauge and aluminium coupons. Different welds will be carried out in the vertical and overhead weld position. On the assessment day the Instructor will overview how the assessment will be carried out, then will check and advise on your practice welds done prior to doing your assessment welds. You have two opportunities for doing each of the seven welds and then you select the best of each weld you would like destructively tested.
- A charge of \$250.00 + GST may be made if cancellation is made within 5 days of the agreed assessment date or if the equipment (as outlined in the Automotive Aluminium GMA (MIG) Welding Qualification Assessment Checklist) is not ready or useable on the day.

**Retesting:**

- To become qualified, all seven welds must meet the visual inspection and destructive tests. Welds that do not qualify must be redone within six months of the assessment date.
- Retests are \$288.00 + GST + travel irrespective of how many welds require retesting.
- The retesting is limited, two consecutive retest failures will require performing all seven welds again.

**Requalification:**

- Requalification every three years requires a full assessment.
- The cost is the same as above.

# PRIVACY POLICY

## *Overview*

1. **General:** I-CAR New Zealand Trust (**we/us/our**) acknowledges and respects the privacy of individuals. This policy sets out the way in which we collect, use, disclose, manage and protect your personal information. It is not intended to limit or exclude your rights under the Privacy Act 2020.
2. **Subject to change:** This policy is subject to change. Any changes will be effective when a notice of the change is posted on our website [www.i-car.co.nz](http://www.i-car.co.nz). Please check this policy periodically so that you are aware of any changes.
3. **Acceptance:** By using our services, our website and/or providing your personal information to us, you are consenting to the collection, use and disclosure of that information as set out in this policy (as amended from time to time).

## *What information do we collect and hold?*

4. **Collection of information:** We may collect and hold personal information about you through your use of our services and our website and through your registration with us (if applicable). Examples of information we may collect and hold, includes (without limitation):
